2. I attach a Key Payment of \$30 (\$20 of which is a refundable bond). If you are a current committee member or a senior interclub captain or a club coach you are entitled to a free club key but you will be liable for the key bond should the key be not be returned for any reason.
3. I understand the gate key bond will be refunded to me should I leave the club upon returning the key to the club, provided I have not breached the club "Key rules"
4. The key bond is non-refundable if your membership has lapsed for one season or longer.

5. I acknowledge and I agree that:
 - All key holders must submit a court key application form.
 - The key remains the property of the tennis club.
 - I will not lend the key to anyone at all, other than a member of my immediate family who is also a club member.
 - I am at all times to assist in maintaining the security of the clubs courts.
 - I will immediately return the key to the club upon request
 - I have read, understood and will abide by the rules of the club, in particular those rules relating to court usage, at all times when on club premises
 - I will promptly notify the club of any change of address, phone or Email as written above.
 - Beachhaven Tennis club shall not be liable for accident or injury to members including unsupervised children accessing club facilities using the Keys.

“KEY RULES”

1. Beachhaven Tennis Club courts are available only to current members except by special arrangement with the Club President.
2. Courts may be used at any times between 6am and 10pm other than Club playing times as generally noticed below.
3. Members keys are not to be loaned to non-members **under any circumstances**.
4. Members must lock the court area while they are playing, and lock up when leaving.
5. Proper non-marking tennis court shoes are to be worn at all times – no running shoes, jandals, or bare feet.
6. Appropriate tennis attire to be worn at all times.
7. No smoking, alcohol, or food allowed on the courts.
8. Lights must be turned off by 10.00pm.
9. Members should occupy a court for a maximum of 1 hour outside club time if other members are awaiting a game.
10. Interclub tennis takes precedence over all other games.
11. Visitors may play as a guest of a member of up to 3 times a year, but a fee of \$5 per visit per player is applicable. The host should pay this to the Club President.
12. One parent practicing with a junior member is acceptable, but where a family uses a junior member’s key, then the guest rule applies to all non-members except on parent.
13. ‘Mid Week’ members may play at any time between 9am and 4pm daily, Monday to Friday, but not weekends.
